HOUSE BILL 2000 By: Caldwell (Trey)

An Act relating to veterans; creating the Oklahoma Department of Veterans Affairs Act of 2021; providing for non-codification; and providing an effective date

HOUSE BILL 1990 By: Caldwell (Trey)

which relates to the Ad Valorem Reimbursement Fund; providing for reimbursement attributable to certain veteran homestead exemptions; providing an effective date;

SENATE BILL 278 By: Montgomery

which relates to the State Use Committee; providing exemptions for the Oklahoma Department of Veterans Affairs; adding expiration of temporary exception; and declaring an emergency

SENATE BILL 62 By: Montgomery

which relates to the Oklahoma Strategic Military Planning Commission; modifying termination date; and declaring an emergency.

SENATE BILL 65 By: Montgomery

An Act relating to the Deployed Parents Custody and Visitation Act

SENATE BILL 243 By: Montgomery

An Act relating to the Ad Valorem Reimbursement Fund; amending which relates to the distribution of funds; adding category of exemption for which reimbursement may be claimed and creating qualification; clarifying language; modifying priority for payment of claims; and providing an effective date.

An Act relating to memorial bridge designations; designating the "MSGT Michael Werdehoff Vietnam MIA Memorial Bridge The bridge located on Interstate 44 over State Highway 49

SENATE BILL 70 By: Simpson

An Act relating to higher education which relates to in-state status for dependents of military personnel; modifying eligibility for in-state status for certain students; updating statutory language; providing an effective date; and declaring an emergency

this relates to priority of applications at the Oklahoma Veterans Home;

SENATE BILL 285

By: Simpson

An Act relating to soldiers and sailors; requiring the Department of Veterans Affairs to evaluate the Union Soldiers Home; requiring determination of measures and funds necessary to meet United States Department of Veterans Affairs standards; requiring submission of findings to the President Pro Tempore of the Senate and Speaker of the House; authorizing the Department to seek assistance from the Adjutant General and state agencies; providing for codification; providing an effective date;

SENATE BILL 415

An Act relating to veteran's sales tax exemptions which relate to information for determining eligibility; deleting obsolete language; authorizing disclosure of specified information by Oklahoma Tax Commission to Oklahoma Department of Veterans Affairs relating to certain eligibility; requiring veteran registration for certain sales tax exemption; requiring veteran registration by certain date to remain qualified for certain sales tax exemption; requiring the Tax Commission to promulgate rules; specifying content of rules; providing statutory reference; amending Section which relates to registry of veterans; requiring additional verification of veteran service disability status under certain circumstance
